

- In 2022, 69% of the sector members expressed positive views on financial performance. Around half of the members (46%) estimated their revenue would increase.
- 38% of the sector members believed that the quality of China's investment environment is improving, 17 pp higher than the overall respondents. China ranked as the first or top three near-term investment destinations, cited by 46% of the sector members.
- 54% of the sector members are optimistic about domestic market growth under the two-year business outlook.
- Addressing environmental challenges/environmental protection (38%) and China's policies and initiatives around carbon neutrality (38%) are among the top three business opportunities for the sector members


- 对于其他工业行业会员企业来说,69%的会员企业对2022年的财务状况表现出乐观情绪。约一半(46%)的该行业会员企业预测营收会出现增长。
- 38%的该行业会员企业表示中国整体投资环境有所改善,较所有受访会员企业结果高出17个百分点;同时,46%的该行业会员企业表示中国是其公司近期首要或前三大投资目的地。
- 超半数 (54%) 的该行业会员企业对今后两年在华业务展望持较为乐观的态度。
- 该行业会员企业表示"解决环境挑战/环境保护"(38%)和"中国的'双循环战略'"(38%)是其在华运营的前三大机遇。













Estimated Revenue





China ranks of near-term global



















